



NORTH TAHOE PUBLIC UTILITY DISTRICT  
RESIDENT'S BENEFIT PROGRAM

**What is CFD 94-1?** A Mello Roos assessment passed in 1992 by the residents of the North Tahoe Public Utility District to support the North Tahoe Regional Park and other recreational amenities provided by the District. Funds collected from this tax measure support operations and maintenance of the District's Park facilities. In 2010, CFD 94-1 provides approximately \$500,000 for District Parks staffing and facilities maintenance. No property tax money or other funding sources go toward operation.

**Who is Eligible?** Those paying CFD 94-1 as part of their property tax bill are eligible for the Residents' Benefit Program. District residents or renters who don't pay the CFD 94-1 tax can come in with a copy of a utility bill in their name showing the address of a property within the District and join the program for \$42, which will entitle you to one Resident's Sticker. Renters may also request that the owner or property management company assign the benefits of the property to you.

**What benefits do I get?** Each parcel that pays the full assessment is eligible for two (2) vehicle stickers. A third or fourth sticker can be purchased for 1/2 the cost of that year's assessment rounded to the nearest dollar, currently \$42.00 each. The program allows free parking at the North Tahoe Regional Park and discounted parking at Kings Beach State Recreation Area, Tahoe Vista Recreation Area and Coon Street Parking Area as well as discounted launch rates for the Coon Street and Tahoe Vista Boat Launches. The Benefit Program offers discounted rates for use of Regional Park facilities as well as at the North Tahoe Event Center and a 10% discount with all District concessionaires.
