Tahoe Vista Recreation Area Facility Pricing and Information

Tahoe Vista Recreation Area Plaza

Private Events

The paved plaza area is available for weddings, parties, reunions, etc.

4 Hour Minimum (Including time for set up and clean up)

25% discount available for Monday – Thursday non-holiday rentals.

\$350 Security Deposit

- Tables, chairs, propane grills, etc. are not included in rental and, if needed, must be coordinated and rented by renter.
- Charcoal grills are not permitted at Tahoe Vista Recreation Area.
- Parking at the facility is limited at this time.

Plaza Public Events

- \$450/day for 150 attendees or less. Rental rates for groups larger than 150 people begin at \$450/day and will be adjusted dependant on impact to the facility.
- Zero Waste Events may qualify for a discount. Final rates determined upon submittal of application to the District.
- Security Deposit \$350 for Events under 50 people, \$500 for events 50 – 150 people, and \$1500 for large events.

Picnic Area – Tahoe Vista Recreation Area

Resident	\$50 for 2 tables for 4 hours
Non-Resident	\$60 for 2 tables for 4 hours

Rentals are available in two 4-hour blocks, 10 AM – 2 PM and 3 PM – 7 PM. Rentals which include both time blocks include the 2-3 PM time period at no extra charge.

Security Deposit \$50

- Charcoal Grills are not permitted and people must provide their own gas/propane grills.
- No more than 6 tables may be rented at a time in a given weekend to allow for first come, first served use.
- Groups that reserve picnic tables may only utilize the picnic tables they have rented. Those renting tables and then utilizing remaining tables reserved for “first come, first served” rentals may not be permitted to rent tables for a one year period and/or may be charged the full security deposit as rental for use of the “first come, first served” reserved tables.
- Parking at this facility is limited at this time.

Kings Beach Facility Pricing and Information

Kings Beach Plaza - Public Events Only

- Public Event Rates begin at \$350/day for 150 attendees or less.
- Rental rates and Security Deposit for groups larger than 150 people will be adjusted dependant on impact to the facility.
- Security Deposit \$350 for Events under 50 people and \$500 for events 50 – 150 people, \$1500 for large events.
- Zero Waste Events may qualify for a discount. Final rates determined upon submittal of application to the District.

Picnic Area - Kings Beach

Facilities include 6 picnic tables and 4 grills. All are available for rental.

Resident	\$60 for 2 tables for 4 hours
Non-Resident	\$80 for 2 tables for 4 hours

Rentals are available in two 4-hour blocks, 10 AM – 2 PM and 3 PM – 7 PM. Rentals which include both time blocks include the 2-3 PM time period at no extra charge.

\$50 Security Deposit

- Rentals include use of a Charcoal Grill. Charcoal not included.
- All tables at the specified picnic rental location are available for rent, however unreserved tables are open to the public on a first come, first served basis.
- Groups that reserve tables may only use the picnic tables they have rented. Those renting tables and then utilizing remaining tables reserved for “first come, first served” patrons may not be permitted to rent tables for a one year period and/or may be charged the full security deposit as rental for use of the “first come, first served” reserved tables.

Adjustment of Fees and Charges

The Park and Facilities Manager, with the approval of the General Manager, has the authority to create special rates when such would be in the best interests of the District, after taking into consideration the time of the year, nature of the client, the reservation status of the facilities, capacity and utilization of the field and other related factors.

Such special pricing shall be on a one-time basis and not create a precedent for other users of the facility or future rates. Any special pricing must cover all incurred operating costs associated with use of the facility.
