# What is the Youth Trust Fund?



*Try something you've never done before!  
You never know what you might be good at!*

The Youth Trust Fund was established in order to provide the young people that reside within the North Tahoe Public Utility District an opportunity to participate in recreational activities

that may not otherwise be available to them.

The North Tahoe Recreation and

Parks Commission administers the fund. They raise money at the annual pancake breakfast that takes place the morning of the Kings Beach Snow Festival parade.

## Philosophy & Mission Statement

To provide the youth of the North Tahoe Public Utility District with opportunities to participate in recreational or enrichment activities (sports, recreation, arts, music, Scouts) that may not otherwise be available to them due to financial difficulty.



## How do I apply?



Scholarships are available for all youth activities that are not supported by any other scholarship program. Similarly, individual participation in sports

programs of the Tahoe Truckee Unified School District (TTUSD) will be considered on a case by case basis.

All requests must be from local youth residing within the North Tahoe Public Utility District boundaries.

All requests for funding shall be made on the Commission's "Scholarship Request" form. This form can be found on the Parks website, [www.northtahoe.com](http://www.northtahoe.com) and then clicking on Community Funds and then Youth Trust Fund.

Requests shall be accompanied by a recommendation from a teacher, school official, or another third party who shall state how participation in the requested activity will benefit the youth. The Commission requests that the person recommending the student notifies the District when and how

the community service is completed.

The Trust Fund will cover up to 80% of the program cost to a maximum of \$100 per request, up to \$200 annually.

When appropriate, if the applicant is over age 12, the recipient of a distribution from the Youth Trust Fund shall



participate in a minimum of four hours of Community Service, with volunteer hours at the Recreation and Parks Commission Pancake Breakfast the highest priority. Those that do not intend to volunteer at the Pancake Breakfast must request that their family member or person submitting the letter of recommendation notify the District when and how the community service has been completed.

Upon receipt of requests that meet all the above criteria, District staff, with the approval of the Recreation and Parks Commission, shall issue a request for distribution of funds on behalf of the child.

Applications must be received prior to the start of the program or class.
